as may be required by the competent authority.
3. that the society shall apply for recognition by 60 days.
at the least duly fulfilling the conditions.

4. that the permission accorded is restricted to this year only and it is not valid for the subsequent, academic year.
5. that this permission does not confer any right on the society for obtaining recognition.
6. that the permission is accorded to **Shriya Lakshmi Educational** Society and not other society or body can open a school on their behalf.
7. that permission is accorded to open the school premises in the locality and shiksha thar shall not be by others in the premises or locality.
8. the society shall provide the necessary material even if it costs more than the deposit amount.
9. **One section in each class.**
